**Summary of Free Tax Preparation & E-files Services:**

**AARP Tax-Aide Program** - Free Federal & State E-file tax preparation services are provided by certified volunteers with primary focus on taxpayers aged 60+. No adjusted gross income (AGI) limit. Check for type of returns volunteers are certified to do. Not all are within scope of certified volunteers.

**VITA Program** - Free Federal & State E-file tax preparation services are provided by certified volunteers for taxpayers generally with an AGI of \$50,000 or less. No age limit set for qualified taxpayers. Check for type of returns volunteers are certified to prepare. Not all are within scope of certified volunteers.

**Assisted-Self Help Program** - Also referred to as **VITA FAST**. Taxpayers with good computer skills and who qualify (age 52 or younger with an AGI of \$57,000 or less (unless the taxpayer qualifies for an EITC or military return) can e-file their Federal & State taxes free of charge with minimal help from a certified volunteer. Check for type and complexity of returns volunteers can assist with or answer questions to. Not all are within scope of the VITA FAST program.
